

It is understood that The Rights of the persons with Disability Act 2016 has been enacted and put into implementation. Necessary guidelines have also been issued by Government of Tamilnadu under GO MS NO 51 DT 25-12-2017.

Under these, Reservation has been provided vide clause 34 (1) (d, e) for one percent in The case of intellectual disability, specific learning disability and mental illness, and also stated, The appropriate Government shall identify posts in the establishment which can be held by respective category of persons with bench mark disabilities in respect of vacancies reserved in accordance with provision of 34 in the act 2016. Necessary instruction has been given by Government of India vide clause 33 of the Disability act 2016.

Under these context with reference to the section 6 of right to Information Act 2005
The following information is required and relevant fees paid and affixed herewith.

1. Whether the rights of the persons with disability according to Disability act 2016 has been implemented and eligible persons have been appointed in any of the Government departments both in Central government and State government of Tamilnadu.
2. If so how many persons have been appointed from 2016 to till now in Government Departments/establishments and, the names of such departments.
3. Whether the Reservation quota of one percent has been fulfilled or carried over to the Next subsequent appointment.
4. Also whether Government has identified the posts in the establishment which can be Held by respective category of persons with bench mark disabilities in accordance With the provision of clause 34 of disability Act 2016.

The above in formations may please be provided to me as per the Right To Information act 2005 to the address as mentioned below .
