We have received number of representations from Technical Officer-A those were promoted through Assessment from pre-revised pay scale of Rs. 5500-9000 to Rs. 6500-10500. On implementation of 6th Central Pay Commission in the Institute both the pay scale were merged in PB-2 9300-34800+4200 GP and accordingly they were placed in same Pay Band as they were holding before promotion through Assessment.

To remove this anomaly the Govt. of India has issued an OM No.F.No.1/1/2008-IC dated 13-11-2009 regarding grant of the revised pay structure of grade pay of Rs. 4,600 in the pay band PB-2 to posts that existed in the pre-revised scale of Rs. 6500-10500 as on 1.1.2006 and which were granted the normal replacement pay structure of grade pay of Rs. 4200 in the PB-2 on the following ground.

"Commission recommended that on account of the merger of 3 scales i.e. 5000-8000, 5500-9000 and 6500-10500, some posts which constituted feeder and promotion grades would come to lie in an identical grade. The Commission gave specific recommendations in its Report graning higher grade pay of Rs. 4600/- to some categories of these posts. As regards the other posts, the Commission recommended that it should first be seen if the posts in these 3 scales can be merged without any functional disturbance and if possible, the same should be done. Further, the Commission recommended that in case it is not feasible to merge the posts in this pay scale on functional consideration, the posts in the scale of Rs. 5000-8000 and 5500-9000 should be merged with the posts in the scale of Rs. 6500-10500 being upgraded to the next higher grade in the PB-2 with GP 4600/-."

large number of reference from Administrative Ministries/ Departments proposing upgradation of the posts which were in the pre-revised scale of Rs. 6500-10500 as on 1.1.2006 by granting them grade pay of Rs. 4600 in the pay band PB-2, the Govt. of India vide decided that the posts which were in the pre-revised scale of Rs. 6500-10500 as on 1.1.2006 and which were granted the normal replacement pay structure of grade pay of Rs. 4200 in the pay band PB-2 will be granted grade pay of Rs. 4600/- in the pay band PB-2 corresponding the pre-revised scale of Rs. 7450-11500 with effect from 1.1.2006. The OM of Govt. of India is placed in the File as Annexure-A.

We may implement the above OM in the Institute as the post of Technical Officer-A is feeder and promotion grade for the post of S.T.A. in the Institute. As both the posts are for different means, therefore it is not feasible to merge STA & Technical Officer-A in PB-2 with grade pay Rs. 4200/-

In view of the above and implementation of 6th Central Pay Commission in the Institute, it is proposed to grant grade pay of Rs. 4,600 in the pay band PB-2 to posts that existed in the pre-revised scale of Rs. 6500-10500 as on 1.1.2006 and which were granted the normal replacement pay structure of grade pay of Rs. 4200 in the PB-2.
